

# Privacy Policy

## Introduction

We believe that transparency is the key to any healthy relationship. We appreciate that you are trusting us with information that is important to you, and we want to be transparent about how we use it. Here we describe the privacy practices for Tahira. You will learn about the data we collect, how we use it, the controls we give you over your information, and the measures we take to keep it safe. Here are some key factors: We may anonymize, de-identify and/or aggregate the information that we collect and use such anonymized, de-identified and/or aggregated data for commercial, statistical and market research purposes, including sharing it with affiliates and business partners. You own your personal data, and you're always in control. Therefore we offer you several ways to control the privacy of your personal information and we're constantly striving to improve the functions and features needed in order for you to be feel that you're in control. Our privacy policy (the "Privacy Policy") is here to give you all the information you need about what kind of information we collect, how we use, how we share it, how you control your data, and make sure you know your rights in connection to when you use our applications, software, websites, APIs and services (collectively, "Tahira"). When it comes to third party products or services or the practices of companies that we do not own or control, including other companies you might interact with in or through Tahira, this Privacy Policy does not apply to them, unless indicated otherwise. This Privacy Policy establishes a legal agreement between you, as the user of Tahira. Throughout this Privacy Policy we will refer to you as "you", and we will refer to Tahira (as the developer behind Tahira) as "we", "us" or "Tahira". ## Processing of your information

Tahira relies on a number of legal bases to collect, use, share, and otherwise process the information we have about you for the purposes described in this Privacy Policy, including: Where you have agreed to the processing. For example, if you have entered your email upon registering to our online backup service. Please note you can revoke this at any time. To fulfill the contract of service between Tahira and you as a user of the application Tahira. Where necessary to comply with legal obligation, a court order, or to exercise and defend legal claims. Where you have made the information available public. Why we do this is, first and foremost, in order to provide and improve Tahira services. In addition, it is also to enable us developing tailored offers to you as a user on a continuous basis. As well as, in order to keep Tahira safe and secure, protecting it against fraud, spam and abuse etc.

## Information we collect

When you interact with our services, we collect information that, alone or in combination with other information, could be used to identify you. When you sign up for or use the Services, you voluntarily give us certain Personal Data, such as your email address. If you register for an account through your social media account (including Facebook and Google Sign-in), you may see which of your friends are using the Services. The information we get from these accounts depends on your settings and the privacy policies of the social media

platforms, so please check those policies to understand the privacy practices of those platforms.

## **Sharing of information**

We may share non-personal information that is aggregated or de-identified so that it cannot reasonably be used to identify an individual. We may disclose such information publicly and to third parties. Only information needed to perform these specific actions will be shared with third-party services, nothing more. We will never share more information than necessary. Service and Hosting Providers Tahira may share your personally identifiable information with third parties (like hosting and market analytics) for the purpose of providing services to you. If we do this, such third parties' use of your information will be bound by restrictions consistent with this Privacy Policy. Publicly available Information This Privacy Policy shall not apply to any information you post to the public areas of the Services. Comments posted to public areas may be viewed, accessed, and used by third parties subject to those parties' privacy practices and policies. Legal requirements We may preserve or disclose information about you to comply with a law, regulation, legal process, or governmental request; to assert legal rights or defend against legal claims; or to prevent, detect, or investigate illegal activity, fraud, abuse, violations of our terms, or threats to the security of the Services or the physical safety of any person. If we are involved in a merger, acquisition, financing due diligence, reorganization, bankruptcy, receivership, sale of all or a portion of our assets, or transition of a service to another provider, your Personal Data and other information may be transferred to a successor or affiliate as part of that transaction. But all of this will be managed in correspondence to this privacy policy.

## **Information Security**

Pursuant to applicable Data Privacy laws and regulation, Tahira maintains a reasonable technical and organizational measures to protect information against accidental or unlawful destructions, or loss, alteration, unauthorized disclosure or access. We work hard to keep your data safe. We use a combination of technical, administrative, and physical controls to maintain the security of your data. This includes using Transport Layer Security ("TLS") to encrypt our Services.

## **Data Retention**

We keep your account information, such as your email address, and password, for as long as your account is in existence because we need it to operate your account. We keep other information, like your activity data, until you use your tools to delete the data or contact us for a full erasure, because we use this data to provide you with your personal statistics and other aspects of the Services. We also keep information about you and your use of the Services for as long as necessary for our legitimate business interests, for legal reasons, and to prevent harm. If you wish to cancel your account or request that we no longer use your personal information to provide you the Service, you may delete your account by sending a request to delete your account to [\[email protected\]](#) We may also delete your account if it has been inactive for a certain amount of time. Preceding the delete request it may take up to 30 days to fully delete your personal information from our systems. Information about you that is no longer necessary and relevant to provide our services may be de-identified and

aggregated with other non-personal data to provide insights, such as statistics of the use of Tahira.

## **Our Policies for Children**

We appreciate the importance of taking additional measures to protect children's privacy. Tahira does not knowingly collect Personal Data from children under the age of 16. If you have reason to believe that a child under the age of 16 has provided Personal Data to Tahira through the Services please contact us and we will endeavour to delete that information from our databases.

## **Changes to this privacy policy**

Tahira reserves the right to change this Privacy Policy from time to time. We will inform you of any changes by posting the updated Privacy Policy through the mobile applications. If we make any material changes to our Privacy Policy, we will post a notification through the mobile applications and/or by asking you to review the changes to the Privacy Policy the next time you access the Services. Your continued use of the Services after the changes are made will indicate your consent to our use of your information consistent with this Privacy Policy, including those changes.
